Annual boat trailer parking permits are available for purchase by residents, to park in the areas listed below. Permits are limited to two (2) per household. The permit sticker issued by the city must be visibly attached to the front lower right side of the boat trailer to be valid. **Please refer to the graphic on the backside of this form for correct placement of sticker.** Please be advised that parking regulations and hours vary by location, so be sure to adhere to posted signage at the boat launch and parking areas. ***On-street and overnight boat trailer parking is not allowed within the city.*** Vehicles and watercraft found to be in violation of city ordinances or parking regulations may be ticketed and/or towed.

**Boat Launch Boarding Dock and Boat Trailer Parking Regulations**

**Boarding Dock**

- Open daily April 1 – November 1, 6:00 a.m. – 11:30 p.m. (weather permitting)
- For temporary use of loading and unloading passengers and watercraft only (20 minute maximum)
- Loitering, fishing, swimming, sunbathing and other similar activities are prohibited

**Parking Lot #1 – Andersen Corporation**

- Open daily May 1 – September 30, 6:00 a.m. – 10:00 p.m.
- Limited to five (5) stalls on weekdays; twenty (20) stalls on weekends/holidays
- Parking limited to designated area adjacent to the launch (refer to attached map and signage at launch)

**Parking Lots #2 and #3 – Lakeside Park**

- Open daily, year-round, 6:00 a.m. – 11:30 p.m.
- Parking limited to designated areas (refer to attached map and signage at launch and Lakeside Park)
